




## Portland Symphony Orchestra Magic of Christmas

## Friday, December 12, 2025





**EVENT:** The Portland Symphony Orchestra, established in 1923, is a fully professional symphony that is recognized as being one of the top orchestras of its size in the country. Join us as we travel north to Portland to see the amazing Portland Symphony Orchestra perform their hugely popular seasonal performance Magic of Christmas. Eckart Preu, Music Director of the orchestra strikes up the biggest band in town for Maine's finest holiday extravaganza. This is one performance you do not want to miss! We will be using our new ADA wheelchair accessible van for this trip! Two accessible seats have been reserved for us at the Merril Auditorium in Portland, however they must be confirmed by May 1, 2025. After April 31, we will only be offering non ADA seats at the show.

Lunch is included in your registration fee.

**<u>DATE:</u>** The date selected is Friday, December 12, 2025. We will depart the Exeter Recreation Center parking lot at 10:15am and will be returning to Exeter approximately 6:00pm.

**<u>FEE:</u>** The fee is \$57.60 (residents) or \$72.00 (non-residents) per person, that includes lunch, admission to the Magic of Christmas performance (2:00PM show) and transportation in the Recreation Department ADA van.

**DEADLINE:** The deadline to register Friday, December 5, 2025, or once the van is sold out.

Note: We need a minimum of 8 people registered. Max of 24 people.

**<u>REFUNDS:</u>** No refunds after tickets/reservations have been purchased unless we can find a replacement for your spot in the program.\*

\*Medical Injury/Illness Policy: If there is a medically documented injury/illness we will prorate a refund after we receive written medical varication from your physician which must be received prior to the trip.

<u>GUIDELINES</u>: Registrants must sit in the same seat(s) on the return trip as they sat in on the first part of the trip. **If** you have a need requiring you to sit in a particular area, please let the Recreation Office know when you register for the trip. The staff will relay to the trip escort that he/she needs to be sure you get the necessary seat. **Parents** are expected to have complete control of their children at all times throughout the trip.

Exeter Parks & Recreation Department sponsored trips are designed to provide members of the Exeter Community - families, friends, and individuals alike - with safe, relaxing and enjoyable sports and entertainment experiences. To ensure these goals, the Exeter Parks and Recreation Department has established a policy of prohibiting the possession and use of alcohol and other drugs while on board.
