Introduction

This report highlights overall participation in the October 19, 2024 Household Hazardous Waste Collection. This collection was funded by municipal assessments, participant donations, and a grant received by the Rockingham Planning Commission from the NH Dept. of Environmental Services.

2024 Collection Overview

The October 19, 2024 HHW collection event was held at the Exeter Public Works Garage from 8:00AM-12:00PM. Residents from East Kingston, Epping, Exeter, Newfields, Seabrook, South Hampton, and Stratham could participate in the event.

2024 Total Participation

In 2024, a total of 313 households participated in the HHW collection region-wide. This is down slightly from the 2023 total of 358 households but up from 2022 and 2021.


The table below shows the number of households that participated in the collection event from each municipality and the corresponding percentage of the total participants. For comparison, it also highlights the population of each municipality and its percentage of the total population. Most municipalities saw participation rates that were consistent with their populations.

Information Sources


Region-wide, websites provided the largest source of information to participants; 26% reported learning about the collection through a website. Websites were also the most widely used source of information in 2023, 2022, 2021, 2019, and 2018. Several entities have websites that list the HHW collection event, including Rockingham Planning Commission, NH Dept. of Environmental Services, and each participating municipality. In 2024, there were 291 clicks on the collection event registration page from the Exeter Town website (www.exeternh.gov) and 80 from the Rockingham Planning Commission website (www.therpc.org). 17% of participants learned about the event through their Town Hall and 15% reported learning about the collection from social media, which was an increase from 9% in 2023. In 2024, there were 91 clicks on the collection event registration page from Facebook.



Materials Collected

The October 19, 2024 HHW collection manifested a total of 15,317 pounds of waste. Of this, 5,556 pounds were hazardous; 8,541 pounds were non-hazardous; and 1,220 pounds were universal waste. There was a drop in the amount of waste collected per household this year.

The composition of waste collected through the October 19, 2024 HHW event, as reported on participant surveys, is shown below. The top 5 types of items collected in 2024 were the same as in 2023, 2022, and 2021. Oil-based paint, solvents, and thinners were the most common items received; 43% of participants brought these items to the 2024 collection event. Household cleaners were the next most common item collected (35%), followed by pesticides (28%), antifreeze and other automotive liquids (28%), gas/diesel/kerosene (26%), used motor oil (23%), and fluorescent bulbs (23%).
