Presentation Dover Solid Waste Study Approach and Findings (Dave Dinzeo, Dover Solid Waste Advisory Committee)

- Dover explored if they could do their own trash/recycling pickup Dover funded a consultant to evaluate this
 - Consultant suggested:
 - Moving from manual truck pickup system to automated trucks with toters (needs a two year lead time) – committee suggests this
 - Moving from pay as you throw model to utility billing system to fund this

 committee suggests this
 - Utility billing system ended up being very expensive so Dover is looking at adding trash to the general tax bill
 - Dover take this on rather than hiring a company to manage committee does not suggest this
 - This takes a lot employees and Dover has this found this to be quite expensive and it is tough to get and keep employees
 - Belmont, Portsmouth, and Stratham have moved in this direction and Dover has learned from them
 - o Turnkey landfill is currently slated to close by 2034
